

## OFFICIAL RULES - CUSO Investment Services Post-Webinar Survey Giveaway

Giveaway Entry Period: General Electric Credit Union's (GECU) CUSO Investment Services ("Sponsor) Post-Webinar Survey Giveaway (the "Giveaway"), is ongoing beginning Wednesday, January 1, 2025 at 12:00:00 AM Eastern Time ("ET") and ends on Wednesday, December 31, 2025 at 11:59 PM ET (the "Giveaway Entry Period"). The giveaway will only be tied to any indicated CUSO Investment Services webinars held throughout the 2025 year. Any material submitted outside the giveaway Entry Period will not be eligible for an entry.

**Random Drawing**: The winner will be selected and notified by CUSO Investment Services, on or about seven (7) days following the webinar, from all the eligible entries received during the giveaway Entry Period. Odds of winning depend on the number of eligible entries received.

**Prize**: There will be one (1) prize awarded per webinar. The selected winners will receive (1) \$100 Gift Card. The prize is not transferrable. The winner is solely responsible for reporting and paying all applicable state and federal taxes.

You do not need to be present for the drawing to win, however it is the responsibility of the entrant to fill out the contact form to be selected as a winner. If the prize is unclaimed, the prize may be forfeited and awarded to an alternate winner.
